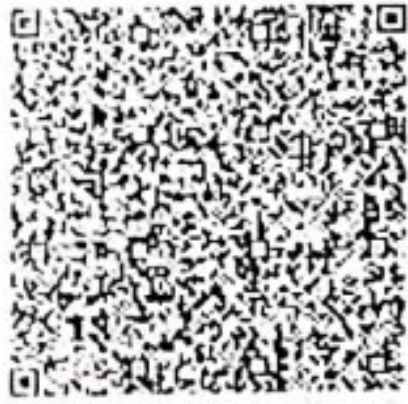

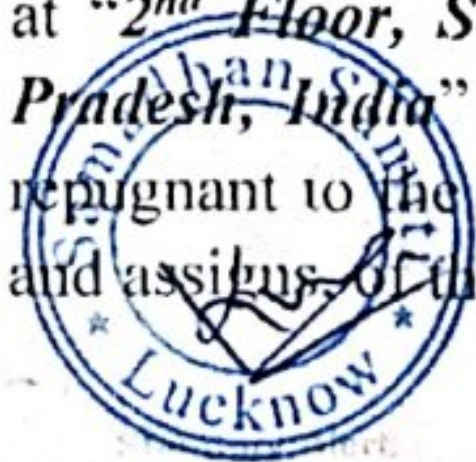

BACKGROUND & PURPOSE:

A.
